Schoen reported on his unsuccessful attempts to gain access to the Middlesex Freeholders' public web site and said that he is working on a letter to the county's IT professional. Schoen also reported the Middlesex Freeholders' upcoming meeting schedule.

## MUNICIPAL WATCH

### **Paff v. Perth Amboy - Loitering Ordinance**

Mayor Vas was quoted in the August 8, 2004 Star Ledger (attached) that the ordinance will be repealed.

### **Nuisance Ordinance - Cranbury**

A follow-up letter and OPRA request (attached) was sent to the Cranbury Health Department on August 23, 2004.

### **Nuisance Ordinance - Edison**

Schoen signed an August 24, 2004 letter to Councilman Patel that was drafted by Paff (attached). Paff suggested that Schoen may wish to attend a future council meeting and speak during the public portion if he doesn't get a substantive response to the letter.

### **Nuisance Ordinance - Franklin**

Paff reported that he filed an Amicus Curiae brief (attached) in Franklin Municipal Court challenging the constitutionality of the nuisance ordinance and will argue the cause on Thursday, August 26.

### **Letter to Prosecutor RE: Franklin "Interference with police" ordinance.**

Moved by Paff: Resolved, that the letter dated August 26, 2004 and addressed to Joseph V. Rocchietti be mailed or delivered to the addressee with copies to the officials named on page 2 of that letter. (see attached). Carried.

### **Lawsuit - Edison Township**

Paff reported that default was entered against Edison's clerk on July 30, 2004 due to her failure to answer. On August 4, 2004, Attorney for Edison moved to vacate the default. Our lawyer, Richard Gutman, consented to the vacation of default and oral argument on our summary judgment motion has been postponed to Friday, September 24, 2004.

### **Court Records in Readington**

Paff reported receipt of a August 2, 2004 letter from Carol A. Welsch (attached) informing that AOC is considering a statewide citizen complaint probable cause procedure and form based on our suggestion.

Paff reported a new issue—should the Readington Court have handled the probable cause hearing on a citizen complaint against one of its own officers as it did in the Teeple matter? The letter from Judge Gross, mentioned above, suggests that the Readington judge should not have conducted the hearing but should have sent it to another court.
